Council Business

- ♦ Council accepted the “Regional District of Nanaimo Regional Growth Strategy Bylaw No. 1615.01, 2016”.
- ♦ Council instructed staff to include a separate survey relating to Town services to be included in the OCP survey mail out, as the Quality of Life Survey should not be the vehicle for Town services evaluation.
- ♦ Council appointed Councillor Horner as Councillor liaison to the Select Committee on Family Day Celebration. Council also amended the terms of reference for the committee and approved the event to be held on May 28, 2017.
- ♦ Council authorized staff to issue a Development Permit for 271 Fern Road East, as attached to the February 27, 2017 Planning memo to Council.
- ♦ Council awarded the contract for the Poplar Avenue Water and Storm Sewer to Hazelwood Construction Services Inc. in the amount of \$486,153.59.
